Executive Summary

In October 2014, the Police and Crime Commissioner took responsibility for commissioning support services for victims of crime to help them cope and recover.

For the financial year of 2015/16 the PCC was allocated £1,276,567 by the Ministry of Justice for the commissioning and/or provision of emotional and practical support services for victims' of crime.

In November 2015, 6 applications for grant funding to provide specialist services to victims of crime were received. Of these applications, three were approved, one application is pending further scoping, one was unsupported as it did not meet the grant criteria and one was unsupported as it did not align with the PCC's commissioning strategy.

A total of £8,235 in grant funding was awarded.

Applications

The following provides an overview of the grant applications received and recommended for approval:

1. Rape and Sexual Assault Referral Centre

To award £3,090 for the provision of counselling assessors to determine what therapeutic approach would be most suitable for clients to meet their individual needs. The funding will also provide a temporary uplift in hours provided by Independent Sexual Violence Advisors to manage an increase in caseloads.

2. Surrey Police

To award £1,700 to Surrey Police to provide specialist training to officers in the use of Domestic Violence Protection Notices/Orders, which are an important power used to protect victims of domestic abuse, keep them safe and afford them the space needed to consider future options.

3. yourSanctuary

To award £3,445 to yourSanctuary to provide specialist training for workers in all Surrey refuges, which will build capability to support clients with complex needs. This will increase refuge accessibility for clients presenting with needs, such as mental health and substance misuse, and ensure workers have the necessary resilience to work in an increasingly complex and stressful environment.

Recommendation
