The PCC met with HMI Zoë Billingham on the 29th February 2016. The purpose of this meeting was a routine catch up and no notes were taken.

Explanation of Exemptions

Section 40(2) Personal Information

If the request for information relates to third parties (anybody other than the data subject), it is an absolute exemption under s40(2) if disclosure would breach any of the data protection principles. This is the case for those documents as indicated above.

Section 31(1)(a)(b)(c) Law Enforcement

- 1) Information which is not exempt information by virtue of section 30 is exempt information if its disclosure under this Act would or would be likely to prejudice
 - a) The prevention or detection of crime
 - b) The apprehension or prosecution of offenders
 - c) The administration of justice

In line with the terms of this exemption we have also considered whether it would be in the public interest to release all of this information to you despite the exemption being applicable. The outcome of the public interest test has favoured the partial disclosure of the information.

When assessing whether or not it was in the public interest to disclose the information to you we took into account the following factors:

Public interest considerations favouring disclosure:

• The police service is seen to be open and transparent

Public interest considerations favouring withholding the information:

• It would reveal and therefore undermine the effectiveness of operational tactics



- It would undermine the partnership approach to law enforcement
- It would hinder the prevention and detection of crime

I would like to take this opportunity to thank you for your interest in the Office of the Police and Crime Commissioner.
