### **Executive Summary:**

For 2017/18 the Police and Crime Commissioner has made available £750,000 of funding to ensure continued support to local community, voluntary and faith organisations.

In April and May the Community Safety Fund, received 7 applications for funding for small grants. Of the 5 are recommended for approval by the PCC. The PCC is also asked to approve funding for an application previously postponed while the Officers gathered more information.

### Applications for Core Service Awards over £5000

### Community Foundation for Surrey - Youth Social Action

To enter in to partnership with the PCC and award the Community Foundation for Surrey £30,000 to support a joint fund which aims to inspire and increase social action in young people.

### Applications for Small Grant Awards up to £5000 – Community Safety Fund

### Felbridge Parish Council – CCTV Upgrade

To award £1,500 to Felbridge Parish Council to upgrade and improve their CCTV provision. The upgrade and increased range of the CCTV will increase security and deter any future criminal damage attempts.

### Surrey Police - Honour Based Abuse Day of Remembrance

To awards Surrey Police £1939.20 towards the running of an awareness raising event on the 14<sup>th</sup> July on Honour Based Abuse Day of Remembrance. Partner agencies as well as Surrey Police Officers will be invited to attend.

## Surrey Police – Surrey ASB Practitioner's Forum

To award Surrey Police £4,000 for the running of three ASB practitioner's Forums. The Forums allow those working to reduce ASB a professional forum to hear good practice, changes in legislation, and opportunities to network and a platform to keep everyone informed about the work of the Surrey ASB Strategy Group.

### Reigate and Banstead Borough Council – Redhill Town Centre Detached Youth Work

To award £4,400 to Reigate and Banstead Borough Council so they can increase the number of hours the detached youth works carry out in Redhill Town Centre. Currently the town centre is seeing an

increase in ASA. The funding will allow training and professional workers the opportunity to engage and work with those young people in the area.

### High Sheriff – Youth Awards

To award the High Sheriff Youth Awards £5,000 to support their work in 'Helping young people make Surrey safer' The awards aims to fund youth clubs, sports clubs or even individual projects that aim to give young people opportunities that will prevent them coming to the attention of the criminal justice system. The agreement will award £5,000 to the High Sherriff for the next three years, subject to a number of outcomes and clauses.

### Recommendation

The Commissioner supports the core service applications and small grants applications to the Community Safety Fund and awards to the following;

- £30,000 to Community Foundation for Surrey
- £1,500 to Felbridge Parish Council for their CCTV upgrade
- £1,939.20 to Surrey Police to run an awareness event on Honour Based Abuse Day of Remembrance
- £4,000 to Surrey Police for the running of the ASB practitioner's Forums
- £4,400 to Reigate and Banstead Borough Council for an increase in detached youth work
- £5,000 to the High Sherriff for their Youth Awards
