### Community Safety Fund Applications – July 2017

#### **Executive Summary:**

For 2017/18 the Police and Crime Commissioner has made available £750,000 of funding to ensure continued support to local community, voluntary and faith organisations.

In July The Community Safety Fund, received 7 applications for small grants. 5 have been recommended for approval. The office also received a request to redirect some previous funding to a new, related project by the Surrey Waste Partnership.

#### **Applications for Small Grant Awards up to £5000 – Community Safety Fund**

##### ***Runnymede Borough Council – Junior Citizen***

To award £5,000 to Runnymede Borough Council towards the purchase of the supporting crime prevention booklets. The books enable schools to continue to teach positive crime prevention and personal safety in the classroom following the Junior Citizen event.

##### ***Guildford Borough Council – Junior Citizen***

To award Guildford Borough Council £5,000 towards the purchase of the supporting crime prevention booklets. The books enable schools to continue to teach positive crime prevention and personal safety in the classroom following the Junior Citizen event.

##### ***Runnymede Borough Council – Truss Island***

To part award Runnymede Borough Council £2,000 towards the purchase and installation of gates which will act as a long term solution to prevent access to the area after dark and reduce anti-social behaviour.

##### ***Safer Woking Partnership - Junior Citizen***

To award the Safer Woking Partnership £5,000 towards the purchase of the supporting crime prevention booklets. The books enable schools to continue to teach positive crime prevention and personal safety in the classroom following the Junior Citizen event.

##### ***Claygate Recreation Ground Trust***

To award £4,988 to the Claygate Recreation Ground Trust as a contribution towards the re-build of the Clubhouse following a fire. The award will fund the necessary crime prevention recommendations, namely CCTV and a burglar alarm.

## **Surrey County Council – Surrey Waste Partnership**

To agree to alter the funding agreement of the 15 July 2016 so that the Partnership can purchase Selecta DNA products for the purpose of detecting and deterring fly tipping offenders and offences. £2596.27 that is remaining will be redirected to purchase the Selecta DNA products.

### ***Applications not recommended/deferred by the panel - redacted<sup>1</sup>***

#### ***Viewpoint Centre CIO - Restart***

Recommendation not to award £4,800 to Viewpoint Centre to work in partnership with Tandridge Youth Intervention Team to identify and refer six young people (8-24 years) who are engaging in antisocial behaviour, at risk of offending or re-offending within the local community to help them build core emotional and thinking skills through high impact, horse powered interventions called The ReStart. It was felt that with the changes to youth services it was appropriate to fund such a project.

#### ***40 Degreez – Health Hub Start Up***

**Recommendation not to award £5,000 to 40 Degreez for the** Yearlong Health Hub start-up project launching September 2017 at 40 Degreez, Farnham. The service will provide a tailored service to support referred young people currently at risk of offending and participating in anti-social behaviour. It was felt that with the changes to youth services it was appropriate to fund such a project.

#### **Recommendation**


The Commissioner supports the core service applications and small grants applications to the Community Safety Fund and awards to the following;

- £5,000 to Runnymede Borough Council to deliver Junior Citizen
- £5,000 to Guildford Borough Council to deliver Junior Citizen
- £2,000 to Runnymede Borough Council for gates at Truss Island
- £5,000 to Safer Woking Partnership to deliver Junior Citizen
- £4,988 to Claygate Recreation Ground Trust for security upgrades
- £2,596.27 to the Surrey Waste Partnership for the Selecta DNA Products
