Executive Summary:

For 2017/18 the Police and Crime Commissioner has made available £750,000 of funding to ensure continued support to local community, voluntary and faith organisations. An amount of £250,000 has been ring-fenced for projects that will reduce reoffending in Surrey.

In September 2017 the Community Safety Fund (reducing reoffending), received 1 application for funding for a small grant.

Applications for small grants £5000 and under

KSSCRC wishes to replicate a successful project in Maidstone and deliver One Stop Shops in Guildford. The overall aim of the One Stop Shop is reduce re-offending and for service users to access support in addressing their offending behaviour. The One Stop Shop works on the basis of a hub of community services being accessible under one roof. The one stop shop will have local agencies and voluntary organisations together and accessible at the Guildford Probation Office. The purpose is for the services to be easily accessible to service users in order for them to address their criminogenic needs and the factors associated with their offending behaviour. The one stop shops will increase service users engagement with partnership organisations and the voluntary sector and therefore be mutually beneficial for all. The idea ensures that the shop facilitates easy and direct access to services and removes the fear of initial contact for service users. The events will also promote joint working with professionals and allow and opportunity for networking.

Recommendation

That the Commissioner supports the application to the Community Safety Fund for a small grant and awards the following;

 £5000 to KSSCRC to produce marketing and promotional material for Guildford One Stop Shop events.
