Executive Summary:

For 2017/18 the Police and Crime Commissioner has made available £750,000 of funding to ensure continued support to local community, voluntary and faith organisations. An amount of £250,000 has been ring-fenced for projects that will reduce reoffending in Surrey.

In February/March 2018 the Community Safety Fund (reducing reoffending), received 4 applications for funding for a small grant.

Applications for small grants £5000 and under

BehindBras - Supporting women inside & out project

With support from Surrey PCC and KSS CRC, BehindBras will identify, assess, recruit and train serving and former female prisoners from five London and the South-East of England prisons so that they progress to become qualified and employable for work in the fashion, retail and creative industries.

The project will provide tangible, targeted and gender informed Through the Gate support to promote employability, desistance and improve social exclusion amongst women prisoners. BehindBras will achieve this by providing pre-employment training and support for serving women prisoners and ex-prisoners who have been released from their sentence.

Elmbridge Rentstart - Outreach service for rough sleepers

This project involves actively seeking out local rough sleepers, or responding to reports from the public who have seen rough sleepers. The outreach worker meets with these clients and attempts to build rapport and strong relationships. Our initial aim is the safety and health of these clients and the outreach worker will ensure that they have food / clothing and access to any medical treatment they may require. The ultimate aim is to build a relationship that enables these clients to come into our offices for an interview which will then enable us to find them housing. Some clients are happy to immediately engage with us fully and seek housing, others need a longer time frame to build up trust in what we can do for them. Once housed we continue to provide practical and emotional support including help with benefits, medical needs, finances and starting to seek employment or training. We expect to meet with 50 rough sleepers over the next 12 months.

Kent, Surrey, Sussex Community Rehabilitation Company – Experts by experience

As part of Making Every Adult Matter, there is a requirement to engage with experts by experience and ensure that experts are involved in the development of the MEAM approach in a locality. Following policy from the MIND charity it is recommended that experts are remunerated for their contributions.
