### Community Safety Fund Applications – July 2018

#### **Executive Summary:**

For 2017/18 the Police and Crime Commissioner has made available £500,000 of funding to ensure continued support to local community, voluntary and faith organisations.

#### **Applications for Small Grant Awards up to £5000 – Community Safety Fund**

***Surrey Police*** – Honour Based Abuse (HBA) Day of Memory for victims of honour killings

To award £1,550 to Surrey Police to run a Multi-agency conference in support of the National Day of Memory for Victims of Honour Killings. The event will be open to police, health, education, social services and voluntary sectors. In Surrey we still have a long way to go for such complex incidents to be recognised, especially as they are hidden crimes, and need to be effectively dealt with, so the risk is not increased to the victim or any secondary and tertiary victims as a consequence.

***Guildford Town Chaplaincy – Street Angels***

To award Guildford Town Centre Chaplaincy £5,000 for continuing their service in Guildford by funding radios, recruitment and equipment. 2018 marks their tenth year anniversary of the Guildford Street Angels initiative which has won countless awards, including the prestigious Queens Award for Voluntary Service, engaging and supporting individuals who find themselves in a vulnerable state, offering practical care in Guildford town centre on Friday and Saturday nights. This funding will support the continuation of this support service.

***Surrey Search and Rescue – Operational Insurance***

To award Surrey Search and Rescue £5,000 towards the running costs of the service, in particular towards the insurance costs to operation the team.

***Surrey Police – County Watch Alert***

To award Surrey Police £400 towards providing a text alert system to those signed up to Country/Farm Watch. This enables those who are predominately outdoors to engage with Surrey Police when they see suspicious vehicles or people and also assist in keeping an eye out for missing people when they do not have enough signal for internet access but are able to receive text messages.

### ***East to West – Relational Support Worker***

To award East to West £4,240 towards a Relational Support Work within Matthew Arnold school in Staines. The RSW based there, has worked with 125 young people over the past academic year 1:1 as well as supporting a dozen through exam stress groups. East to west, hope looks like a young person overcoming the challenges within their life. Hope is a student having the courage to take exams despite anxiety and stress. It is someone stepping away from a life of crime or violence and becoming a positive member of their local community. It is a young person who engages with school and who grows and develops aspirations for their future.

### ***Surrey Police – Hate Crime App***

To award Surrey Police £3,500 towards the innovative app which provides the functionality for people to report Hate Crimes through the capture of videos, visual images (photos, screenshots relating to cyber bullying etc.), audio recordings and identification of geographic locations relating to specific hate incidents as well as providing users with additional information relating to Hate Crime, including the range of support that is available to help those affected by hate crime, including links to partner agency websites.


The Commissioner supports the core service applications and small grants applications to the Community Safety Fund and awards to the following;

- £1,550 to Surrey Police for the Conference on HBT
- £5,000 to Guildford Town Centre Chaplaincy for the Guildford Street Angels
- £5,000 to Surrey Search and Rescue towards their operational running costs
- £4,240 to East to West Trust for a Relational support Worker
- £400 to Surrey Police for the Text Alert Scheme
- £3,500 to Surrey Police for the Hate Crime App
