# **Reducing Reoffending Fund Applications – July 2018**

## **Executive Summary:**

For 2018/19 the Police and Crime Commissioner has made available £250,000 of funding to reduce reoffending in Surrey.

In July 2018 the fund received one application for core funding and one application for a standard grant

## Applications for core funding – 3 years

## Circles South East – Surrey Reducing Sexual Harm Circles Project

To fund Circles South East £32,250 per annum over a three year period (£96,750 total) to enable them to:

- Continue to deliver the core Circle model across Surrey
- Establish the Through the Gate Circles model to assist the transition from custody into the community
- Provide access to the Adapted Circles model for core members with Intellectual disabilities and/or autism
- Provide one to one and paired mentoring support as assessed as appropriate
- Scoping and development of potential to widen the Through the Gate intervention to referrals for indeterminate sentence prisoners who are approaching oral hearings and in cases where officers are recommending release
- Ongoing evaluation of service

Services will support between 12-18 core members over 3 years.

## Applications for standard grant funding

## The Forward Trust – Vision for Surrey

To fund the Forward Trust £26,106 to deliver a through the gate private rented housing offer for their clients on drug and alcohol programmes.

The forward Trust currently deliver substance misuse services to over 900 offenders (clients) across the Surrey prisons cluster (HMP Coldingley, HMP Downview, HMP High Down and HMP Send). In this application, they are proposing to complement this provision by offering accommodation services to these clients so that they can support 18 of them into safe, secure and independent accommodation when they are released from prison.

## Recommendation

The Commissioner supports the grant applications to the Reducing Reoffending Fund and awards to the following;

- £32,250 for up to 3 years, total of £96,750 (subject to grant agreement conditions being met) to Circles South East for delivery of their Surrey Reducing Sexual Harm Circles Project
- £26,106 to The Forward Trust for delivery of their Vision for Surrey housing project
