# Kent Surrey Sussex Community Rehabilitation Company – Through the Gate Mentoring Project

To fund KSSCRC £19,860.50 to continue delivery of a through the gate (TTG) mentoring scheme. The scheme provides a unique, holistic and responsive approach for offenders prior and post release from prison. Release is a crucial and very risky time for offenders due to the complexity of need presented by this particular group, not least of all the poor links with constructive activities and statutory agencies. There is a short window of time when an offender is ready and wanting to make changes. TTG mentoring will include up to 12 weeks support prior and post release.

KSSCRC are dedicated to reintegrating offenders into society and into appropriate services to reduce further offending and support the essential changes required to contribute to that reduction in reoffending and making our communities safe.
