Executive Summary:

At the start of the Covid-19 pandemic in the UK and national lockdown the Police and Crime Commissioner has made available £500,000 from the operational reserve to ensure essential services continue to support local vulnerable residents in Surrey, including those at greater risk due to isolation measures. The emergency funding was made available to those organisations who have already received funding from the PCC in previous years.

Applications for Covid-19 emergency funding

East Surrey Domestic Abuse Services

To award East Surrey Domestic Abuse Services £25,836.34 to ensure outreach services can operate remotely and continue to support survivors of domestic abuse. The funding will allow for the service to increase their opening hours to support victims, police and other front-line services. By working until 9pm the service can provide more resilience. In addition, the funding will allow for the production of extra communication content for six months to increase awareness of domestic abuse and ensure survivors know where they can access help.

Recommendation

The Commissioner supports the applications to the Covid-19 Fund and awards the following to East Surrey Domestic Abuse Service:

Update to telephony systems to facilitate home working: £170.00

Provision of laptops to support staff home working: £3,401.34

Increase in opening hours: £16,500.00

Production of communication material: £5,765.00

Your Sanctuary

To award Your Sanctuary £6,540.00 to ensure outreach services can operate remotely and continue to support survivors of domestic abuse. The funding will also allow for an increase in operation of the domestic abuse helpline and chat service which is likely to see an increase in usage whilst survivors may not be able to access other support.

Recommendation

The Commissioner supports the application to the Covid-19 Fund and awards the following to Your Sanctuary:

- Uplift in helpline and chat service £3,340.00
- Provision of laptops to support staff home working: £3,200.00

North Surrey Domestic Abuse Service

To award North Surrey Domestic Abuse Service £4,752.00 to ensure outreach services can operate remotely and continue to support survivors of domestic abuse. The funding will support the ability of home working.

Recommendation

The Commissioner supports the application to the Covid-19 Fund and awards the following to North Surrey Domestic Abuse Service:

- Provision of mobile phones to support staff home working: £1,400.00
- Provision of laptops to support staff home working: £3,352.00

Waverley Citizens Advice Bureau - Domestic Abuse Service

To award Waverley Citizens Advice Bureau Domestic Abuse Service £644.00 to ensure outreach services can operate remotely and continue to support survivors of domestic abuse. The funding will support the ability of home working and the technical support needed to implement this.

Recommendation

The Commissioner supports the application to the Covid-19 Fund and awards the following to Waverley Citizens Advice Bureau Domestic Abuse Service:

- Telephony solution to reroute landlines: £54.00
- Uplift in contracted tech support hours: £88.00
- Uplift in staff time to support remote working implementation: £644.00
