Funding for the provision of victim services

1.0 Summary

In October 2014, Police and Crime Commissioners (PCCs) took on responsibility for commissioning support services for victims of crime, to help individuals cope and recover from their experiences. This paper sets out recent funding committed by the PCC in fulfilment of these duties.

2.0 Ministry of Justice Independent Domestic Violence Advisor (IDVA) Uplift

The Ministry of Justice (MoJ) has made available to Police and Crime Commissioners funding to support delivery of new IDVA services during 2021/22 and 2022/23.

Following an expression of interest submitted by the Office of the Police and Crime Commissioner, Surrey has been awarded a total of £1,109,214.

This decision record relates to funding due to be released during 2021/22, as follows:


A further decision record for 2022/23 will be issued in due course and on successful implementation of the above services.
