Title: Consultancy Expenditure 2014/15 – Force/OPCC

Purpose of Report/Issue:

To provide members with an analysis of costs incurred in hiring consultants and the reasons for hiring during the 2014/15 Financial Year.

The use of the term consultancy has a wide interpretation however this report uses the definition contained within the Joint Procurement Service guide on the use of consultants:

Consultancy Services are classified as arrangements where an individual or organisation is engaged:

- to provide expert analysis and advice which facilitates decision making;
- to perform a specific, one-off task or set of tasks; and
- to perform a task involving skills or perspectives which would not normally be expected to reside within the Force.

To be classified as a Consultancy Service, an arrangement should meet all of the criteria listed above.

The schedule provided has the consultancy expenditure for over £10k with a brief explanation of the work carried out.
