## Victims Fund – Bridging Grant

### 1.0 Executive Summary

In October 2014, the Police and Crime Commissioner (PCC) took responsibility for commissioning support services for victims of crime to help them cope and recover.

For the financial year of 2016/17 the PCC was allocated £1,372,554 by the Ministry of Justice for the commissioning and/or provision of emotional and practical support services for victims' of crime.

This report includes a recommendation to the PCC concerning the utilisation of this funding.

### 2.0 Recommendations:

#### a) YMCA DownsLink Group

In late 2015/16 the PCC awarded funding for the provision of 2 WiSE Project Workers to deliver targeted interventions to children & young people who are victims of sexual exploitation. The funding was allocated for 12 months of activity, with staff contracts due to expire on 23 February 2017.

WiSE workers provide dedicated support for children and young people affected by CSE to help them cope, recover and rebuild their lives. This complements statutory provision available in Surrey for 14-18 year olds, providing a choice to young people who may be happier working with a voluntary agency and broadening the age range that can be supported.

Children and young people affected by CSE often do not see themselves as "victims" due to grooming that has taken place. The WiSE workers provide both emotional and practical help and better equip them to identify and exit coercive and exploitative relationships.

It remains the Office of the Police and Crime Commissioner's intention to continue funding the service in 2017/18 and it is therefore recommended that the PCC provides a bridging grant to take the service up to the end of the current financial year. The OPCC will then look to issue a new grant agreement to take effect from 1 April 2017.

The cost of extending the current grant agreement is set out below:


