Executive Summary:

The Police and Crime Commissioner is asked to agree to the release of funding from the Community Safety Fund to support the development and delivery of a new Anti-Social Behaviour (ASB) victim's service in Surrey.

A Service for Victims of Anti-Social Behaviour

In 2014 the Surrey ASB Strategy Group, in partnership with the Office of the Police and Crime Commissioner for Surrey and Surrey Police came together to develop a support service for victims of anti-social behaviour in Surrey, with particular focus on those who are at high risk of harm.

The reforms to the ASB tools and powers available to professionals, introduced by the ASB Police and Crime Act 2014, were designed to put victims at the heart of the response to ASB and give professionals the flexibility they need to deal with any given situation. This was a positive step in the right direction but whilst front line staff were dealing with the ASB offenders, those victims that were experiencing repeat incidents of ASB, or are less able to cope due to their vulnerability, needed to be supported better. Therefore, it was agreed a new victim service would be commissioned.

Following a commissioning process a Panel consisting of the OPCC and Surrey Police agreed to recommend the contract be awarded to the **Alliance of Surrey Mediation Services** (**ASMS**). They had proposed to deliver a service which would support victims through listening, coaching and signposting. The service was considered value for money and the ASMS provided a robust delivery timeline and performance monitoring framework. The proposed agreement is for initially for one year (April 2017 to March 2018) with options to extend if the service is proven needed and evaluated as delivering against the agreed outcomes.

Sum required: £60,700
