#### **Community Safety Fund Applications – July 2017**

#### **Executive Summary:**

For 2017/18 the Police and Crime Commissioner has made available £750,000 of funding to ensure continued support to local community, voluntary and faith organisations.

In June The Community Safety Fund, received 15 applications for funding. 8 of those where for application for small grants. Of the 7 core service awards 3 are recommended for approval by the PCC.

### Applications for Core Service Awards over £5000

### Eagle Radio – Ethics and Law Course

To award Eagle Radio £20,000 to deliver assemblies and workshops for state-funded and independent schools with the aim of delivering direct engagement to a second tranche of 24 secondary and 6<sup>th</sup> form schools in the county by September 2017. Eagle Radio will offer schools a full day with a range of opportunities and our work for this period will focus on direct work with students rather than staff or parents. They will continue to ensure that our coverage includes a range of schools including specialist schools focusing on students with specialist educational needs.

## Surrey Community Action – Prevention Through Education

To award Surrey Community Action £10,000 to deliver the Prevention through Education Project (PTEP) wishes to continue and build upon the early intervention and prevention initiative in Years 1 and 2 and continue to provide further education in Year 3 to educate and train the Trustees and Management Committees of Community Buildings and the wider communities in crime prevention.

## C of E Guildford – Bridges Mentoring Project

To award CofE Guildford £23,000 to expand our existing Bridges youth mentoring project into Guildford Borough for a one year trial.

Bridges provides trained volunteer adult mentors to support young people aged 13 to 19 years (with some flexibility in ages) who have been identified as becoming involved in antisocial behaviour, low level crime or who are at risk of offending and /or experiencing other issues. The young people may have completed a police restorative justice programme or be identified through police and youth support officers, home school workers or other statutory agencies as being at risk and potentially benefitting from a mentor. Whilst this is voluntary, the mentor and young person contract to meet regularly over a year and work on identified and agreed aims such as self-esteem, skills for work, anger management etc. Our mentoring scheme is unique in Surrey as it is targeting young people from 13 years and older and supports them for up to a year.

## Applications for Small Grant Awards up to £5000 – Community Safety Fund

## SAVSS – Appropriate Adults

To part award £2,115.50 to SAVSS Appropriate Adult Scheme to support the volunteers in their role as impartial support to those in custody. The project is to provide additional peer support for the volunteers, providing them with space to talk freely and openly about their experiences.

## Spelthorne Borough Council – Junior Citizen

To award Spelthorne Borough Council £5,000 towards the purchase of the supporting crime prevention booklets. The books enable schools to continue to teach positive crime prevention and personal safety in the classroom following the Junior Citizen event.

### Surrey Youth Focus – Crime Prevention Youth Social Action

To award Surrey Youth Focus £1,600 for the further development of the project to promote positive relationships between young people and Surrey Police. The team will deliver two workshops in Surrey schools to support young people turn their ideas into a youth social action project.

### Surrey Police – ASB Awards

To awards Surrey Police £2,000 towards the ASB Awards event. The funding will be spent on venue hire, refreshments and speakers for the evening.

### Surrey Police – Operation Inclusion

To award £1,500 to Surrey Police to run an event to explore how the Force can develop as an allinclusive organisation with an overarching focus on diversity. The funding will go towards the venue hire and refreshments

#### Surrey Neighbourhood Watch Association – Waverley Regeneration

To award the Surrey Neighbourhood Watch Association £250 towards the development and regeneration of the Waverley Watch. The funding will be spent on meeting venues and refreshments.

#### Surrey Police - Stonewall

To award Surrey Police £333 towards a National Trans best practice Tool kit. The cost of the funding

#### Police and Crime Commissioner Sponsorship

As well as the application for funding as listed above the Office of the Police and Crime Commissioner recommends that the following sponsorships are awarded.

#### Active Surrey – Surrey Sports Awards

To provide £1,400 to Active Surrey for the sponsorship of the Surrey Coach of the Year Award at the Surrey Sports Awards.
