Background

A Section 22A agreement has been developed for all Chief Constables and Police and Crime Commissioners (and equivalent) to sign in relation to the delivery of forensic science services in England and Wales.

The Transforming Forensics Programme was established in 2017 to support police forces in England and Wales in delivering sustainable, high quality forensic science capabilities in support of Policing Vision 2025 and the Home Office's Forensic Science Strategy. The Transforming Forensics Programme itself is not a formal collaboration arrangement and is not the subject of any formal collaboration agreement.

As a result of work carried out by the Transforming Forensics Programme the Parties now wish to enter into a collaboration agreement pursuant to section 22A of the Police Act 1996 (as amended by the PRSRA) to establish a Forensic Capability Network (FCN), containing provision relating to the delivery of forensic science services by each of the Parties and/or the collaboration between one or more of the Parties in relation to such delivery. This Agreement also contains provision relating to:

- the support by a policing body for another policing body ("policing body collaboration provision"); and / or
- the support by a policing body for the police force which another policing body is responsible for maintaining ("policing body and force collaboration provision").

The Section 22A Agreement sets out the arrangements for the discharge of the Parties' functions under this collaboration and the appointment of the Police and Crime Commissioner for Dorset to act as the initial Host Policing Body on the terms set out in this Agreement.
