# How your Council Tax helps fund Surrey Police

## Message from David Munro, Police and Crime Commissioner for Surrey

This is the first time in my role as the elected Police and Crime Commissioner that I have carried out the key responsibility of deciding the amount local taxpayers pay towards policing in Surrey.

In my Police and Crime Plan, one of the six priorities is Making Every Pound Count. I am committed to fighting for fair funding for Surrey Police but I also want to ensure that taxpayers pay no more than is absolutely necessary for an effective policing service.

For the 2017/18 financial year, I have set the level of council tax at £224.57 for a Band D property, an increase of 1.99% on last year's figure of £220.19. This amounts to an increase



of around 8p a week over the course of the year. I carried out a public consultation with Surrey residents in which 65% of the 2,100 people who responded expressed support for the

increase. This helped inform my decision which was endorsed by the Police and Crime Panel.

I am confident that the 1.99% precept increase achieves the balance that I am seeking to strike, between fairness to tax payers and fairness to the Police in giving them sufficient resources to keep Surrey safe.

In addition, the Force also has to successfully achieve a challenging savings programme of £5.5 million by the end of March 2018 while the Chief Constable needs £1.4 million from the General Reserve to help fund this year's approved revenue budget.

Across the country, police forces are having to deal with new and changing demands in a



policing environment that has never been more complex than it is today. We are no different in Surrey.

Your council tax will provide the funding to continue to support the strategic objectives of my Police and Crime Plan and the broader force mission of pursuing offenders, protecting the vulnerable and preventing crime and disorder.

It will also help tackle the issue of retaining officers by increasing the South East Allowance and providing added investment in training for our new recruits.

This small increase will enable Surrey Police to concentrate on tackling those areas of crime that are affecting the most vulnerable in our communities whilst providing that balance with the reassuring visible street policing that people have told me is important to them.

I know how much this county's residents value a good policing service. I want to make our communities as safe as possible and continue to provide a police service the people of Surrey can be proud of.

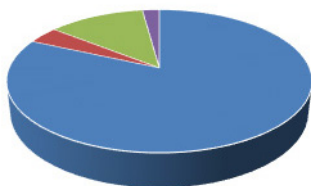

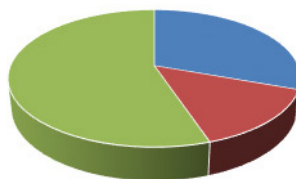
